Calls for changes to public smoking ban



Campaigners seek ban amendments to give pubs and clubs a shot in the arm

A cross-party campaign is calling for amendments to the smoking ban to help save pubs and clubs threatened with closure.

With dozens of pubs and clubs closing every week, the Save Our Pubs & Clubs campaign brings together a wide range of politicians, pressure groups, think-tanks, licensees and other representatives of the hospitality industry.

The aim is to secure amendments to the comprehensive ban on smoking in licensed premises. The campaign's organisers argue that a change to the blanket ban would be fair to smokers and non-smokers and help pubs and clubs that are losing revenue, laying off staff and facing closure.

Award-winning celebrity chef Antony Worrall Thompson, patron of the smokers' group Forest and a leading supporter of the campaign, said: "The smoking ban has had an extraordinarily detrimental effect on pubs and clubs and you can understand why. The legislation as it stands is excessive and I

would like to see it amended."

MPs from the three main parties are supporting the campaign. Greg Knight, MP for East Yorkshire, said: "I fully support this campaign. Britain's pubs and clubs are at the heart of every local community and the UK approach of banning indoor smoking everywhere is damaging the viability of many licensed premises where people wish to smoke. Pub landlords and club committees know best what their customers want and they should be allowed to provide smoking rooms if there is a demand."

Pub closure poster unveiled outside conference

A striking new poster campaign with the slogan "52 pubs are closing each week — act now" was unveiled at the 2009 Labour conference in Brighton. The Save Our Pubs & Clubs poster, below,

Licensees support change to legislation

A letter signed by Antony Worrall Thompson and other licensees who support the Save Our Pubs & Clubs campaign has called on politicians to amend the current smoking ban. "We seek a solution that is fair to smokers, non-smokers and staff alike. We consider it wholly unreasonable that, when up to half of our customers are regular smokers, we can make virtually no provision for them. Separate smoking rooms," it continued, "[would] improve our service without upsetting non-smokers."

Time is right to review the smoking ban, says MP

A Conservative MP has tabled an Early Day Motion calling for a review of the smoking ban. Musician calls for greater tolerance

Writer and musician Joe Jackson has added his name to the Save Our Pubs & Clubs campaign.
A critic of the smoking ban,
Jackson said: "I don't think the Government has any business banning a legal pleasure on private property, especially when the evidence on so-called 'secondhand smoke' is so feeble.

"Nevertheless, I know from experience that the more reasonable partial bans in Germany and Spain are broadly popular because they actually provide some freedom of choice.

"Let pubs and clubs have smoking rooms, and when they're not big enough to do so let them decide their own policies. Better still, promote good ventilation and more tolerance, a dirty word to the anti-smoking zealots."

Jackson has also written to Health Secretary Andrew Lansley, giving him 10 reasons why the ban should be amended.
